1. The Breeder guarantees that the puppy is registered with KUSA registry. No 1033725
2. The Breeder acknowledges that all aspects of the KUSA puppy have been discussed with the Buyer and that no information is withheld from the Buyer.
3. The Buyer agrees to notify the breeder if he cannot keep the KUSA puppy for any reason during its lifetime. The Breeder will assist in placing the KUSA puppy in another mutually acceptable home.
4. The Buyer agrees that he or she will never place the KUSA puppy or its offspring, if decided to breed with the animal, at any shelter, pound, pet store or public sales situation.
5. The registered puppy may not be sold or given away by the Buyer without written permission of the Breeder, who shall have the right of the first refusal.

HEALTH CERTIFICATION

1. The registered puppy is free from signs or symptoms of disease or any congenial defects as of date the puppy leaves the Breeder to the best of the Breeders knowledge.
2. The Buyer agrees to have the registered puppy examined by a registered practitioner veterinarian within 72 hours after receiving the puppy.
3. The Buyer shall notify the Breeder immediately if any medical illness is identified during the veterinarian examination.
4. The buyer shall produce a medical report issued by the veterinarian that undertook the examination and hand the registered puppy back to the Breeder within five days of the date of purchase.
5. The Breeder would refund the Buyer the full amount paid or would replace the KUSA puppy at its sole discretion. The Breeder will not be liable for any illness that develops after the first five days after purchase.
6. The puppy is guaranteed until one year of age against genetic congenial defects, which would cause death or the need to humanely destroy. In such an unlikely case, a written report by a registered practitioner veterinarian is required. The puppy will be replaced or the original purchasing price will be refunded at the sole discretion of the Breeder.
7. The Buyer would be responsible for the cost of the veterinary examination and all transportation cost to and from the Breeder.
8. Buyer will provide the puppy with nutritious food and necessary Veterinary care, including de-worming, heartworm prevention and regular vaccinations, including rabies.
9. Buyer agrees that they have thoroughly researched the Miniature Schnauzer breed, and understand the health issues they can possess. Buyer is responsible for all medical costs of puppy – no refunds will be given. This guarantee covers only the original Buyer and is not transferable.

11. The puppy is vaccinated with Nobivac Canine 1-Dappv, de-wormed with Drontal and micro-chipped with {Five Star}.
12. The Buyer would be responsible for the cost of the veterinary examination and all transportation cost to and from the Breeder.
